Filing claims, requests, petitions, appeals, or annuls as requested by the customer and in the form prescribed by the relevant parties; and4. Officially translating laws, rules, and regulations in foreign languages into Lao.
<b>Qualifications needed by the business to get the formality</b>	To obtain license, the following criteria shall be fulfilled: 1. Enterprise registration certificate,2. Two permanent lawyers and more,3. Capital, office and adequate equipment.
