<b>Qualifications needed by the business to get the formality</b>	1. Having irrigation engineers with at least 5 years of working experience as indicated in each scale of irrigation activities.2. The manager of the company must have at least a degree in irrigation and the director of the company must have a certificate in irrigation engineering3. Having sufficient capital and equipment specified for each scale of irrigation activities. The working capital shall cover at least 30% of total intangible assets.4. The company shall meet the conditions for operating irrigation related business.
