Who should apply for this formality?	The breeder of new plant variety that intends to get the legal protection for their rights under Lao PDR laws within Lao PDR.
Qualifications needed by the business to get the formality	Any individual, legal entity or organization eligible to submit an application is as follows:1. any breeder as defined above may file an application for breeder's rights;2. where two or more persons have jointly bred a new variety, such persons may jointly apply for plant breeder's rights. In the absence of any special declaration of the apportionment of ownership, they are presumed to be owners of equal part of the concerned variety;3. a foreign individual, legal entity or organization shall enjoy within the territory of the Lao PDR the same treatment as is accorded to Lao nationals, subject to the requirement that a party that does not have a residence or business premises shall appoint a representative with such premises in the Lao PDR.
