<b>Who should apply for this formality?</b>	Individuals or legal entities that intend to establish export-import companies in the field of drug and/or medical product
<b>Qualifications needed by the business to get the formality</b>	<p>1. Shall have a Lao pharmacist or pharmacist assistant (Mid-Level Practitioners) in Lao National which has a diploma or certificate of completion in the pharmaceutical profession granted by the relevant educational institution both domestic and international. Licensed by the MoH and have at least 5 years of experience in the pharmaceutical field. If is a government officer, must have an official appointment letter, must be a person that is not under trial or abandoning the position or facing disciplinary actions due to the error in pharmacist profession or dealing narcotics;</p> <p>2. The setting of import-export business must have an area of at least more than 20 square meters, is a specific room, not mixed with residential or accommodation and other non-pharmaceutical or medical products retailer;</p> <p>3. Have a clean place to store products and meet the standard of minimum width 6 meters, 12 meters length and an appropriate height, have the accounting clearing system, animals and insects prevention system and cooling system, lighting, temperature and humidity monitoring system. Inside the warehouse must have necessary equipment, a refrigerator with a temperature not to exceed 2-8 Celsius with temperatures measuring devices in the case of drugs to be kept in cold temperature such as rectal suppository or other drugs (Good Wholesaling Practice (GWP) and Good Storage Practice).</p>
