Once the authorities receive the application, they will request the comments from the district mayor through the District Office of Agriculture and Forestry, related government offices as well as from the village office where the land locates. After gathering comments from related offices, the authorities will take around 5 working days for issuing the permit (refers to the Decision of Department of Agriculture and Forestry of Vientiane Capital, No. 207/DAF.VTE, dated 17 January 2011)</p>
