<b>Who should apply for this formality?</b>	Any individual or legal entity intending to get a lease or a concession of the state land - the request for legitimate rights of using the state land for any business operation in accordance with the conditions and terms defined under the agreement. Investment projects that need a lease or concession of the state land such as: 1. Industrial business 2. Service business in tourist areas 3. Service and accommodation business 4. Stadium business 5. Agricultural business 6. Forest plantation business 7. Mining business 8. Casino business 9. Special Economic Zone 10. Other businesses
<b>Qualifications needed by the business to get the formality</b>	1. The lease or concession of the state land for specific purposes shall be determined by permitting the leased area by not exceeding the areas defined for those purposes i.e. industrial factories, industrial zone, agricultural operations, and mining operations). 2. In case the leased area overlaps with the areas owned by others, the leaseholder shall pay fair compensation to them; 3. The applicant shall submit the feasibility study, the environmental and social impact assessment, and get the approval from the relevant lined agencies; and shall obtain the investment license to operate such business that the leaseholder applied such lease for.

If the project gets a 30-year concession of land, and the developer gets permission to extend the project for 20 more years, then the permit shall be extended for 20 years as the concession agreement.
