Shall have a minimum 20% of technical staff who are Lao citizens and have High Diploma in Transportation field with at least 2 years of working experience. 3. Shall have minimum registered capital of 5 billion LAK. 4. Shall have at least 20 trucks with 100% technical capacity. 5. Must be a big enterprise and have advance technology. In case of foreign-invested company, a foreign shareholder shall not hold share more than 49% of the total capital.
