What is the process and conditions to renew the formality?	- The certificate is valid for 1 year, after reaching the deadline within 1 year, the operator must make a request letter for the annual technical inspection. Technical inspection committee will inspect the actual condition of the vessel, if the vessel is not in normal condition, it must be modified and repaired as in normal condition; Operators have complied with the above conditions and paid taxes in accordance with the law;
