Qualifications needed by the business to get the formality	Applicants wishing to apply for a signage business license must have a location (office location), a feasibility study, vehicles, technical equipment, capital to ensure their operation, and must have personnel with signage skills, ethics and qualifications as required by the Law on Signage.
