<b>Qualifications needed by the business to get the formality</b>	1. Be a recruitment agency obtaining a business operating license for domestic and overseas recruitments, and shall operate the business at least 60 days before the expiry date of the license.2. Have a registered capital and secure funds as defined in the laws.3. Have a representative agency in the receiving countries in order to contact, coordinate and support Lao labour.4. Have a labour market and employees certified by the local authorities.5. Have the internal labour regulations approved by the Labour Management sector.6. Have a labour supply contracts, contracts between recruitment agencies, and the contract between the employers and the workers.(Decree on Sending Lao labour Abroad, No. 245/PM, Article 13)
